The primary goal of ALGHMF is to achieve capital appreciation, and it does so by distributing its resources across various non-conventional investment strategies. A List Group Holdings oversees the allocation of the Fund's assets, entrusting them to sub-advisers and investment funds that primarily employ alternative investment strategies. Additionally, a portion of the Fund's assets is directly managed by A List Group Holdings.

In its pursuit of the Fund's investment objective, A List Group Holdings strives to maintain an investment portfolio with an average level of volatility that is lower in comparison to broader equity markets.

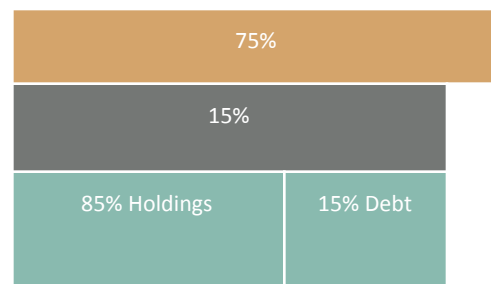

The Adjusted Expense Ratio is the Expense Ratio net of Excluded Expenses. Excluded Expenses include various categories not eligible for reimbursement.
